Superintendent Hospodar shared with the trustees about the upcoming disaster drill to be held on October 19. He shared that preparing for this drill involves a comprehensive review of the school's emergency response procedures and ensuring that all staff members and students are well-informed about the protocol to follow in such situations. Drills are conducted to identify any potential weaknesses that may arise. Such potential weakness will be addressed and remediated in preparation for the unlikely event of a real disaster.

Superintendent Hospodar also shared about a new program being implemented at Wilson School. The WatchD.O.G. Dad program has been brought to Wilson School to encourage males to volunteer at the child's school. Having positive male role models will provide needed support in

the classroom, and additional eyes on the school playground. The program officially begins on October 16th.

Lastly, Superintendent Hospodar shared with the trustees the changes in staffing. Wilson School's speech pathologist resigned and the services provided will transfer to Presence, an online service. Wilson School has worked with Presence during the 2022-23 school year and has found their services impactful on student learning.
